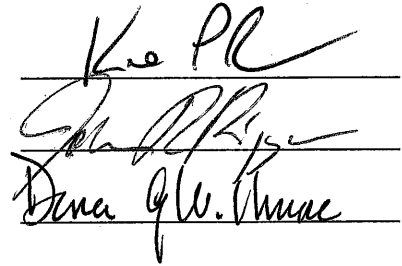


**BUCKLAND BOARD OF SELECTMEN**

2. **Documents to Sign**

- a. **DEP Grant Contract** – Ms. Llamas said this is the small incentive program grant from DEP; a combined contract for \$1700.00; would like to consider installing a hand dryer for the public restroom. Mr. Fox moved to approve the DEP Grant Contract; Ms. Willmore seconded. **VOTED** unanimously in favor.
- b. **Fiscal Year 2013 CDBG Disaster Recovery Contract Amendment** – Ms. Llamas said we have been waiting for this for the bridge on Clesson Brook Road; an additional \$250,000 to complete that bridge. Mr. Fox moved to approve the Fiscal Year 2013 CDBG Disaster Recovery Contract Amendment; Ms. Willmore seconded. **VOTED** unanimously in favor.

3. **Agenda Items**

- c. **CDBG 2015 – North Street Engineering Bid Phase II and III Award** – Ms. Llamas said we are doing Phase I next summer. Our proposal is to do engineering for sections II and III going forward. Kevin moved to award the North Street Engineering Phase II and III to GCG contingent on the reprogramming of CDBG funds, for tasks 1 – 6, in the amount of \$24,795.00; Ms. Willmore seconded. **VOTED** unanimously in favor.
  - a. **2017 Budget Preparation/Calendar** – Ms. Llamas gave the Board a calendar of budget meetings.
  - b. **2016 – 2018 Mowing Bid** – Mr. Fox moved to award the mowing bid for Mary Lyon cemetery, the Buckland Rec, the Police Station, the Highway Facility, and Town Hall to Canepari Landscaping LLC, and the Road Side Mowing bid to Bear River Landscaping; Ms. Willmore seconded. **VOTED** unanimously in favor.
  - d. **Conway, South and Summer Streets and Conway Road (TIP Project) Engineering – Nitsch Engineering** – Ms. Llamas gave the Board the Nitsch proposal for their review.
