**1. Appointments**

**6:40 p.m., Sean Addison** – Follow-up interview for Highway Driver/Laborer position. Sean Addison said he has all of the licenses required for the job, appreciates the job security and benefits.

**2. Documents to Sign**

c. **Curb Cut Permit – Cemetery Road** – Dena Willmore moved we approve the Curb Cut Permit on Cemetery Road; Rob Riggan seconded. **VOTED** unanimously in favor.

d. **Time Off Request** – Dena Willmore moved to sign the Time Off Request; Rob Riggan seconded. **VOTED** unanimously in favor.

a. **Appointment to MCAP** – Energy Committee to submit names.

b. **Appointment to Recreation Committee** – Rob Riggan moved we appoint Jamie LaRue to the open position on the Recreation Committee; Dena Willmore seconded. **VOTED** unanimously in favor.

c. **Appointment of Chief Procurement Officer(s)** – Dena Willmore moved we name Mr. Riggan as the Chief Procurement Officer along with Andrea Llamas; Rob Riggan seconded. **VOTED** unanimously in favor.

d. **Highway Garage – Owners Project Manager, RFQ Final Draft** – Dena Willmore indicated she had read through it. Will await Kevin Fox's input.

**4. Items Not Reasonably Anticipated by Chair 48 Hours in Advance of Meeting – Request for Extension for Fiscal Year 2015 Audit** –Dena Willmore moved we request an extension for the Fiscal 2015 Audit; Rob Riggan seconded. **VOTED** unanimously in favor.

Dena Willmore moved we make an offer to Sean Addision at \$17.85 per hour with a 90-day probationary period, and after that, depending on Mr. Daby's recommendation, pay up to \$18.21 per hour, to start work on July 11, 2016; Rob Riggan seconded. **VOTED** unanimously in favor.

Steve Daby gave a road update – base coat tomorrow on North Street, working on the sidewalks; should be complete in a couple of weeks. He indicated Bray Road is going very well; we will get more paved than originally anticipated.
