- ° Assumption that folks with EV not paying gasoline tax, which goes toward road repair/bridge repair: in the future may have charge on electric bill to offset gas tax for infrastructure improvement?
- ° Managed Charging best to charge overnight prices best & will even out demand (if use managed charging ability to set it to charge vehicle at certain times)
- ° EV purchases flattening e.g. attempts to develop new types of batteries, delays in solar battery development
- ° Meeting recorded and will be aired on GCTV
